Dear Chairman Holley:

On March 2, 2022, the Western Regional Office, Bureau of Indian Affairs (Region), issued a letter identifying a list of individuals whom the Region's records supported as the last undisputed governmental body of the Te-Moak Tribe of Western Shoshone Indians of Nevada (Tribe). Subsequent to the issuance of that letter, documentation was provided to the Region confirming the following changes to the Te-Moak Tribal Council as constituted prior to the disputed October 2021 elections:

- On March 4, 2021, in Resolution No. 21-TM-38, the Te-Moak Tribal Council accepted
 the resignation of the Vice-Chairman, Juan Arevalo, from membership on the Te-Moak
 Tribal Council. Also on March 4, 2021, by Resolution No. 21-TM-39, the Te-Moak
 Tribal Council seated Alice Tybo as the new Vice-Chairman. Thereafter, on March 31,
 2021, pursuant to Resolution No. 2021-EBC-15, the Elko Band accepted Juan Arevalo's
 resignation and selected Thalia Marin to replace him on the Te-Moak Tribal Council.
- 2. On May 20, 2020, pursuant to Resolution No. 2020-EBC-24, the Elko Band Council accepted Jill Temoke's verbal resignation and selected Davis Gonzales as her replacement. On June 3, 2020, in Resolution No. 20-TM-45, the Te-Moak Tribal Council removed Jill Temoke as a member of the Te-Moak Tribal Council and accepted Davis Gonzales as her replacement.
- 3. On July 6, 2020, by Resolution No. 20-BM-07 and Resolution No. 20-BM-08, the Battle Mountain Band Council selected Julia Oppenhein and David Carrera to serve on the Te-Moak Tribal Council. Their selection was thereafter accepted by the Te-Moak Tribal Council by Resolution No. 20-TM-62.
- 4. On August 5, 2020, by Resolution No. 20-TM-78, the Te-Moak Tribal Council accepted Paula Garcia as a representative from the Wells Band.
- 5. On June 16, 2021, by Resolution No. 2021-EBC-27, the Elko Band accepted the resignation of Robert Brady to the Te-Moak Tribal Council.
- 6. According to meeting minutes of the Battle Mountain Band Council dated October 18, 2021, Clifton Oppenhein submitted his written resignation from the Band Council.

Thus, according to the records of the Western Regional Office, the membership of the last undisputed Te-Moak Tribal Council was:

Our letter of March 2, 2022, is hereby modified accordingly. It is reiterated that our interim recognition of this Council is for the limited purpose of transferring judicial jurisdiction from the CFR Court to the Tribe pursuant to 25 C.F.R. § 11.104. It is not a general letter of recognition, does not finally resolve the present Te-Moak intra-governmental dispute, and is not a final decision regarding the validity of the Tribal Court or the Tribal Judge. That is a matter for a tribal forum.

For the reasons set forth in the Region's letter of March 2, 2022, this letter is not subject to review under 25 C.F.R. Part 2.11.
